Minutes of the Meeting held on Friday, Sep 15th 2023 at 5:00PM in the presence of Sylvie Masserey Anselin, President of the Municipality of Chalais Vercorin, and Olivier Gétaz for VercoR2.

Footpaths on the Mont

Following the registration of permanent easements, it is now possible to walk from the Bourgeoisie picnic area to La Crevache via a path "derrière le Mont", or to Les Crêtes and the "Impasse du Mont", following work carried out during the summer of 2023. Signposting will take place in spring 2024. Another variant is being studied, which will leave close to the impasse des Vornys to join La Crevache, as was possible in the past; patience is still required, as negotiations to register right-of-way easements are underway.

Allocated taxes BASIC WATER TAX AND BASIC SEWAGE and WASTE TAXES

The new regulations will be presented at the primary council meeting in December 2023. The Vercorin R2 should benefit from the same pro-rated conditions as the Val d'Anniviers R2.

One thing is certain: Vercorin is short of water, and we have to get it from our "neighbors". In other words, water meters will have to be installed in all new buildings in the medium term. The new bylaw specifies that water meters must be installed in all new buildings, as must equipment to recover roof water.

The basic waste tax has been reduced by 30% to CHF 155.50 (formerly CHF 221.70). The account was in the black.

Waste Disposal Center

After a difficult start, it is now running smoothly. Admittedly, there is still a computer problem with the cards for holders of several dwellings (the system had not allowed for 1 card per dwelling for holders of several dwellings).

The old waste collection center has reopened for green waste only.

As for the Eco points, we're looking for solutions, especially for the one at the entrance to the village, which isn't very attractive, but nothing concrete yet. If you have any ideas, please let us know.

Energy Transition, Potential Subsidies for R2 of Vercorin

The Municipality will create an energy transition fund of CHF 1 million to renovate, insulate, change windows, etc. and equip all the municipality's public buildings with solar panels, among other things. Future savings will go into a fund which, I hope, will enable Vercorin homeowners and R2s to benefit from subsidies. A by-law will also be presented at the primary session in December 2023.

Creux du Lavioz

Pending investment in a new "restaurant", the Municipality has decided to invest in the sanitary facilities at the Creux du Lavioz by renovating and enlarging them.
